## OUR PACKAGES

Each package is for a fixed cost depending on which package or add on service you choose. You pay the service provider for each service you take at the fixed cost.

### BRONZE PACKAGE £3,350

Includes:

Initial meeting with a mediator and counsellor.

3 x 90 minute sessions with a mediator (includes preparation of summaries of proposals).

1 hour of time for each party with a lawyer (this may be a solicitor, legal executive, or non-practising solicitor working as a Professional McKenzie Friend).

The mediator will prepare documents summarising the proposals you feel will work for you.

A consent order prepared by a lawyer for one party and an hour with a lawyer for the other party to check the consent order. The clients will lodge the consent order with the court themselves.

A counselling session for each party (for 60 minutes).

### SILVER PACKAGE £4,610

Includes:

Initial meeting with a mediator and a counsellor.

4 x 90 minute sessions with a mediator (includes preparation of summaries of proposals).

3 hours of time for each party with a lawyer (this may be a solicitor, legal executive, or non-practising solicitor working as a Professional McKenzie Friend).

The mediator will prepare documents summarising the proposals you feel will work for you.

A consent order prepared by a lawyer for one party and an hour with a lawyer for the other party to check the consent order. A lawyer will send the Consent Order to the court for you.

A counselling session for each party (for 60 minutes).

### GOLD PACKAGE £6,050

Includes:

Initial meeting with a mediator and counsellor.

5 x 90 minute sessions with a mediator (includes preparation of summaries of proposals).

4 hours of time for each party with a lawyer (this may be a solicitor, legal executive, or non-practising solicitor working as a Professional McKenzie Friend).

The mediator will prepare documents summarising the proposals you feel will work for you.

A consent order prepared by a lawyer for one party and an hour with a lawyer for the other party to check the consent order. A lawyer will send the Consent Order to the court for you.

A counselling session for each party (for 60 minutes).

3 hours with a Chartered Financial Planner for advice regarding pensions or financial investments used jointly or individually.

## EXTRAS

Any additional work undertaken beyond the above is charged at the rates set out below.

1 hour of further advice from a lawyer for either party charged at £240 inc VAT.

1 hour of advice from a non-practising solicitor working as a Professional McKenzie Friend charged at £90.

Further mediation sessions charged at £300 per 90 minute session.

Further counselling sessions charged at £65 per 1 hour session.

Seeing children in mediation, £96 inc VAT for each parent.

Consultation with a child psychologist, includes free consultation followed by a fixed fee plan for further work to help support your child.

Divorce coaching at £90 per hour.

Fixed cost arbitration with a family arbitrator if you are unable to resolve one or more issues. Arbitration is a private alternative to the court process used, save for certain specific exemptions, to achieve an adjudicated resolution in both financial remedy and Children Act Proceedings. Fees are subject to agreement in each individual case but are likely to be:

Determination on submission of written statements to include drafting of the award: £2,000 plus VAT.

Determination via one day oral hearing to include drafting of the award: £3750 plus VAT.

(If further days are required for the oral hearing these are likely to be charged at £1,500 plus VAT per day).

£250 per 1 hour for further financial advice sessions.
